The 2023 IAAF is returning as an in-person event held at the Federal Deposit Insurance Corporation (FDIC) L. William Seidman Center, with some portions available virtually for individuals unable to attend in person.

The 2023 Interagency Accessibility Forum (IAAF) is sponsored by the Federal Chief Information Officer Council's (Federal CIO Council) Accessibility Community of Practice (ACOP) and hosted by the Government-wide IT Accessibility Program from the Office of Government-wide Policy (OGP) of the General Services Administration (GSA), the U.S. Access Board (USAB), Federal Deposit Insurance Corporation (FDIC), and Department of Veterans (VA) Affairs in partnership with other federal agencies.

The IAAF Planning Committee invites government employees, and contractors in partnership with government employees to submit proposals for consideration to host a workshop, presentation, or panel discussion.

#### **Submission Details**

Authors of successful submissions will be notified by **July 14**, **2023**, with final presentations due by **September 8**, **2023**. Authors will be provided with a template for generating a consistent, accessible format for presentations.

The proceedings for this event will be published online and (potentially) in hard copy form. The accessible electronic copy will be included in the symposium registration.

Most sessions are 45 minutes, but there are a few 60-minute and 90-minute slots available, if needed. The following presentation formats are available:

- Presentations (hybrid)
- Panels (hybrid)
- Workshops (in-person only)

The event organizers will schedule an instructional webinar (date TBD) to help authors with developing and delivering accessible presentations.

Acceptance notifications will go to authors on July 14th. All those who have an accepted session or workshop will be required to submit their final presentation by September 8th.
