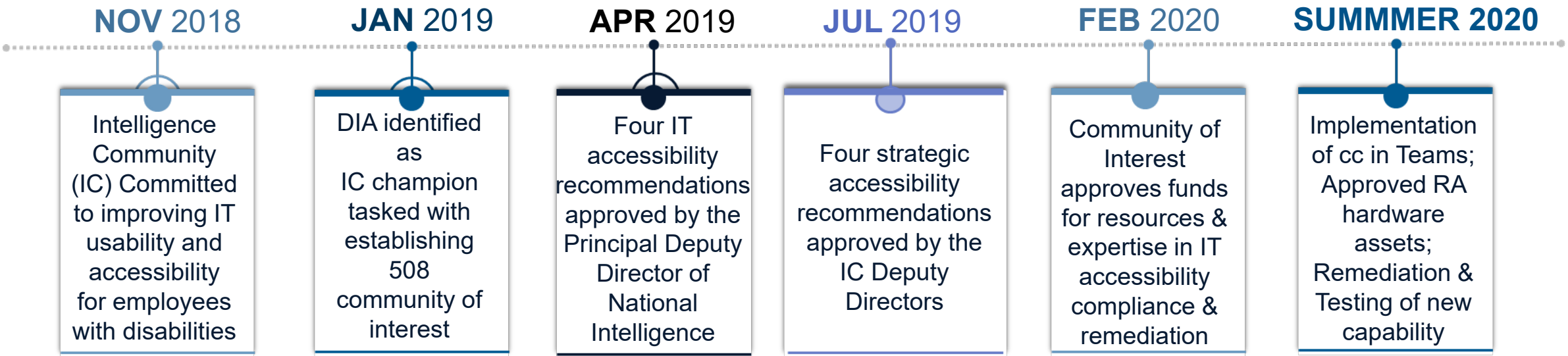

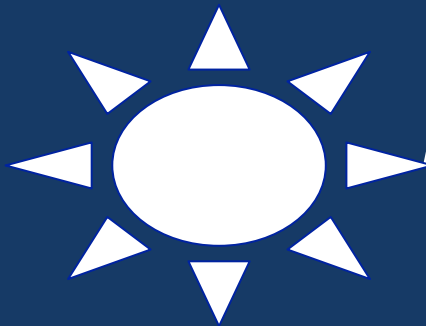
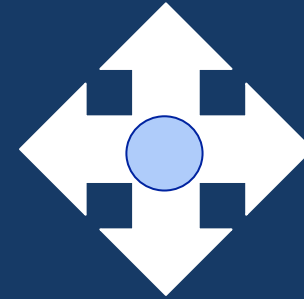

Accessibility Statutory Authority



The Rehabilitation Act of 1973 (as amended in 1998) gives GSA and the U.S. Access Board shared statutory responsibility for providing technical assistance to individuals and agencies on the implementation of Section 508 of the Act. This responsibility is formally delegated to OGP in the GSA Delegations of Authority Manual.



The Strategic Plan for Improving Management of Section 508 of the Rehabilitation Act (OMB 2013), and several previous OMB Memorandums established federal roles for managing Section 508.

Section 508 Federal Strategic Plan

OMB set the stage for the current Section 508 Program Strategic Plan: Improving Management of Section 508 of the Rehabilitation Act

“A framework to enhance and sustain management improvements to increase the accessibility of electronic and information technology”

- 1) Outlines a consistent foundation for agencies to build, mature, and sustain a successful accessibility program
- 2) Established the current biannual Section 508 Program Maturity IDC reporting process
- 3) Focuses on three core tenets:
 - a) Increase transparency;
 - b) Strengthen accountability; and
 - c) Improve collaboration

Federal Coordination on Section 508

How it works

- **U.S. Access Board** sets the legal guidelines and standards
- **GSA** provides technical implementation support to agencies, and manages the Biannual 508 Program Maturity Report
- **ACoP** acts as a bridge between the CIOC and CAOC, corrals resources, and formalizes agency engagement
- **DHS** built the Trusted Tester Program
- **DoJ** is responsible for law enforcement
- **Agency Section 508 Program Managers** are the front line, provide training to their agency, and coordination with their acquisition and development teams
- **OMB** sets the strategic direction & reinforces the priorities
